JOB DESCRIPTION AND PERSON SPECIFICATION
ENVIRONMENT AND CONSENTS OFFICER

Reports to: Technical Manager

Purpose: Support the acquisition, maintenance and streamlining of all statutory consents required at EMEC or other identified sites. Deliver consenting and environmental technical expertise into EMEC projects.

Responsibilities

1. Maintain EMEC's site-wide consents to ensure they remain appropriate for activities at the site, including offshore and onshore.
2. Support the identification and acquisition of consents to facilitate EMEC's projects, including emerging technology areas.
3. Engage with stakeholders and maintain relationships to ensure the regulator, consultees and local stakeholders are effectively consulted on activities across EMEC's projects.
4. Facilitate EMEC's clients in acquiring the necessary consents and consent compliance thereafter.
5. Assist with the development of the streamlined consenting procedure at EMEC and implement efficiencies and improvements.
6. Support the development and delivery of consenting and environmental monitoring services / projects at EMEC, ensuring projects are delivered to budget, schedule, and client's satisfaction.
7. Contribute to industry learning through participation in conferences/ workshops/ seminars and when required input to consultations, particularly with regard to relevant policy.
8. Build on EMEC's environmental expertise to further develop technical services delivered by EMEC. Contribute to environmental survey work and dissemination of key results.
9. Contribute to business development proposals for consenting and environmental projects related to EMEC's core business and facilities.
10. Ensure that the EMEC Integrated Management System is adhered to and assist the Quality Manager and others with identifying and progress improvement actions, supporting EMEC's accreditation by the UK Accreditation Service (UKAS) or other relevant body.
11. Work closely and flexibly with all EMEC staff from across the business.

12. From time to time carry out other assignments which may differ from the above as instructed by line management.

Person specification

Education

Essential – Educated to HND level in a science, business or technical subject, preferably related to the marine environment.

Desirable – Educated to degree level in a relevant technical or scientific subject, preferably related to the marine environment.

Skills and knowledge

Essential – Writes well for a variety of audiences (e.g. technical, regulatory, management). Influencing and communication skills. IT literate.

Desirable – Critical and analytical skills. Knowledge and experience of environmental legislation (particularly in Scotland) and good environmental management practices. Proficient in GIS mapping software. Knowledge of the challenges of working in the marine environment. Good presentational skills. Interested in policy development.

Personal attributes

Essential – Natural team worker. Good attention to detail. Demonstrable willingness to learn. Self-motivated. Positive bias towards renewable forms of energy.

Desirable – Completer-finisher. Can maintain a calm approach when placed under pressurised conditions.

Experience

Essential – Some knowledge of statutory consenting and/or environmental assessment.

Desirable – Practical experience of working within a statutory consenting regime and/or environmental assessment background.

Special conditions associated with the role

1. Travel may be required for certain meetings, conferences, etc. (as necessary).
2. Opportunities to complete environmental survey work with colleagues will be available.
3. The role is based in Orkney.
